### I agree to the following conditions and hereby request a booth at Ferguson StreetFest 2011

1. While festival management will attempt to limit the number of vendors selling a specific product, we will NOT guarantee exclusivity on any vendor products.
2. ALL VENDORS MUST PROVIDE THEIR OWN UTENSILS & TABLES.
3. If ELECTRICITY is needed, vendors must supply their own cords, which must be heavy duty and at least 50 feet long. Anything that draws more than 20 amps will not be allowed.
4. All food vendors must take care of their own St. Louis County Health Applications.
5. All vendors must be setup and ready to sell at least 15 minutes prior to the festival opening.
6. The vendor area will be closed to ALL vehicle traffic 30 minutes prior to the festival opening.
7. *The vendors must commit to vending the entire two-day duration of the festival and are expected to stay until 11pm each night, unless prior arrangements have been made with SF management. No refunds will be given to those who leave early.*
8. Overnight security will be provided on the festival grounds; however, Ferguson StreetFest is not responsible for any items left in a booth.
9. When vendors use their own tents, they must be secured and weighted.
10. No tape or stickies may be used on festival tents - USE CLIPS PLEASE.
11. THE FESTIVAL HAS EXCLUSIVE RIGHTS ON ALL BEER AND ALCOHOL SALES.
12. Vendors are allowed to sell water, soda and other non-alcoholic drinks.
